

We project that carbon emissions will decrease over the next five years to 255.4 tCO2e by 2029. This is a reduction of 23.8 %

#### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2024 baseline and the measures will be in effect when performing the contract.

- All 4 company cars are EV's and charged on renewable electricity
- Implement lock up procedure to ensure all items and lights are off
- Engage waste disposal company to ensure maximum recycling of waste and minimal incineration
- Reception lights activated on PIR sensors

#### **Future Carbon Reduction Initiatives**

In the future we hope to implement further measures such as:

- Negotiate with landlord to use renewable office energy
- Reduce business travel emissions by only visiting South Africa quarterly
- Reduce commuting emissions by increasing working from home and awareness of the benefits of car sharing
- Reduce commuting emissions by exploring 'Bike to work' scheme
